A JOINT RESOLUTION OF THE BOARD OF COMMISSIONERS OF MILLER COUNTY, GEORGIA, AND THE MAYOR AND COUNCIL FOR THE CITY OF COLQUITT; PROVIDING FOR AN AMENDMENT TO THE MILLER COUNTY/CITY OF COLQUITT RECREATION SYSTEM; PROVIDING FOR THE RESTRUCTURING OF THE BOARD AND ESTABLISHING PROCEDURES, RULES AND REGULATIONS GOVERNING ITS OPERATIONS AND FOR OTHER PURPOSES; AND TO REPEAL PRIOR INCONSISTENT RESOLUTIONS; AND FOR OTHER PURPOSES

BE IT RESOLVED, by the Board of Commissioners of Miller County, Georgia (hereafter "County") and the Mayor and Council of the City of Colquitt, Georgia (hereafter "City") in respective meetings of each body having been lawfully assembled as follows:

WHEREAS, the City and the County did jointly create a recreation system for Miller County, Georgia and the City of Colquitt, Georgia by Resolution dated February 5, 1985; and

WHEREAS, a joint Recreation Board was created, composed of nine (9) members; five (5) appointed by the Chairman of the County Commissioners and four (4) appointed by the Mayor of the City of Colquitt; and

WHEREAS, because of the change in financing, funding, and practical operation, the City and County are desirous of revising and amending the Parks and Recreation Ordinance as follows:

NOW, THEREFORE BE IT RESOLVED, in consideration of these things and pursuant to O.C.G.A 36-64 1 et sq., the Board of Commissioners of Miller County, Georgia and the Mayor and City Council of the City of Colquitt, Georgia, do hereby approve and adopt this Resolution amending the Parks and Recreation Ordinance adopted on February 5, 1985 and thereby reestablish and restructure the Colquitt-Miller County Board of Recreation as follows:

- (a) The current membership and appointments to said Board are hereby terminated, instanter.
- (b) That said Recreation Board shall consist of five (5) members as follows:

COUNTY

- Chairman of the Board of Commissioners
- Commissioner appointed by the County.
- County Manager

CITY

- Mayor
- City Manager

All elected official positions will be set to a 1 year term, reappointment will be determined by the respected commission/council. County/City Manager positions will be set to 1 year term with automatic reappointment until termination of employment.

BE IT FURTHER RESOLVED: That the Colquitt-Miller County Recreation Board shall be responsible for the employment of the Recreation Director or other such personnel. The Recreation Director shall be subject to oversight of the County and shall provide to the County a monthly report in the form and substance as directed by the County at its regular monthly meeting next.

BE IT FURTHER RESOLVED: That the Colquitt-Miller County Recreation Board shall submit for review its minutes from any prior meeting at the City and/or County's regular board meeting next and present for approval all expenditures minutes and possess all the powers and be subject to all the responsibilities and limitations as provided under O.C.G.A 36-64-5 and

BE IT FURTHER RESOLVED: That, the Colquitt-Miller County Recreation Board shall possess all the powers and be subject to all the responsibilities and limitations as provided herein and under O.C.G.A 36-64-5 and
